Resolution No. 68 of 2009 on the Formation of the National Committee to control smoking and all types of tobacco and tobacco products

The Prime Minister,

Having considered Law No. 8 of 2009 on the control of smoking and all types of tobacco, particularly Article 16 thereof, acting upon the proposal of the Minister of Health, and with the approval of the Council of Ministers,

Has decided the following:

Article I

To form a National Committee to control smoking and all types of tobacco and tobacco products, to be headed by the Minister of Health, with the following membership:

The term of membership of the said Committee shall be two years and is renewable.

Article II

The National Committee to control smoking and all types of tobacco and tobacco products shall form technical committees incorporating members of the National Committee, other entities represented in the Committee or other relevant entities providing assistance; the Minister of Health shall issue a resolution on the designation, composition and terms of reference of these technical committees.

Article III

This resolution shall be implemented by the Minister of Health and the respective Ministers. It shall be effective from the date of issuance and shall be published in the Official Gazette.
