

**RESOLUTION OF BELARUSIAN MINISTRY OF ECONOMICS
No 61 dated March 29, 2010**

ON PRICES FOR TOBACCO PRODUCTS

(as amended by Ministry of Economics resolutions No 73 dated 17/04/2010,
No 102 dated 18/06/2010)

Pursuant to the Decree of the President of the Republic of Belarus No 285 dated May 19, 1999 (item 2) "On Measures to Stabilize Prices (Tariffs) in the Republic of Belarus", the Ministry of Economics of the Republic of Belarus hereby DECREES:

1. To approve the following "Retail Prices for Tobacco Products" as per Appendix 1.
2. To invalidate the resolutions of the Belarusian Ministry of Economics as per Appendix 2.
3. This Resolution shall come into force from the moment of its official publication.

PRICE LIST
"RETAIL PRICES FOR TOBACCO PRODUCTS"

(as amended by Ministry of Economics resolutions No 73 dated 17/04/2010,
No 102 dated 18/06/2010)

CHAPTER 1
GENERAL

1. The retail prices for tobacco products listed in this schedule of prices shall be applied to the tobacco products produced and/or sold in conformance with GOST 3935-2000 on the territory of the Republic of Belarus by all legal entities and private entrepreneurs, irrespective of their affiliation and forms of property.

2. The retail prices for tobacco products listed in Chapter 3 herein include the value-added tax. The retail prices for tobacco products shall be applied by legal entities and private entrepreneurs, dealing with retail trade, in selling tobacco products to the population. The retail prices for tobacco products, less trade discounts set forth in this schedule of prices, shall be applied in settlements between suppliers and buyers who are legal entities and private entrepreneurs.

3. The retail prices for tobacco products are set by cigarette brands, irrespective of their varieties, unless stated otherwise in Chapter 3 herein.

4. If tobacco products are delivered by several wholesale organizations, the discount granted to wholesale organizations shall be divided upon agreement of the parties.

Tobacco products shall be delivered to the buyers from the supplier warehouse at ex-factory prices.

The delivery of tobacco products to the point stipulated in the contract shall be effected at FOB destination prices.

5. Cigars, cigarillos and pipe tobacco, cigarettes of Cigaronne brand and its varieties, produced in foreign countries, shall be sold on the territory of the Republic of Belarus at free wholesale and retail prices formed in conformance with the Instruction on the Method of Forming and Applying Prices and Tariffs, approved by the Resolution of the Belarusian Ministry of Economics No 183 dated September 10, 2008 (National Register of Legal Enactments of the Republic of Belarus, 2008, No 223, 8/19435).

6. The retail prices for the tobacco goods appropriated by the state shall be formed in conformance with the legislation.
