## DIRECTIVE OF THE MINISTRY OF HEALTH, REPUBLIC OF BELARUS November 3, 2011 No. 111

## ON THE INTRODUCTION OF ADDENDA AND AMENDMENTS TO CERTAIN HEALTH AND SAFETY REGULATIONS AND HYGIENIC RULES AND STANDARDS

Based on the Law of the Republic of Belarus, dated November 23, 1993, "On Sanitation and Epidemiological Welfare of the Population" in the version of the Law of the Republic of Belarus, dated May 23, 2000, Statutes of the Ministry of Health of the Republic of Belarus, approved by the Ruling No. 1446 of the Council of Ministers of the Republic of Belarus, dated October 28, 2011, "On Some Issues Raised by the Ministry of Health and Measures for Implementation of the Decree No. 360 of the President of the Republic of Belarus, dated August 11, 2011", Ministry of Health of the Republic of Belarus RULES:

- 1. Enter additions and amendments to the following sanitation norms, rules, and hygienic standards:
  - 1.1. has expired;

- 1.6. to supplement the Health and Safety Regulations, Hygienic Rules and Standards, "Hygienic Requirements for the configuration, equipment, and maintenance for the facilities of an anatomical pathology office, departments and laboratory organizations in healthcare," ratified by Directive No. 84 of the Ministry of Health of the Republic of Belarus, dated May 3, 2008, following item 7 item 7-1 of the following content:
- "7-1. The director of an anatomic pathology organization is obliged to ensure that the development and execution of a set of measures for implementing the prohibition of smoking (consumption) of tobacco products on the grounds and in the buildings of the anatomic pathology organization, with the exception of areas specially designated for this purpose.";

Ministry of Health of the Republic of Belarus, dated February 13, 2009, after paragraph 4, the subparagraph 41 with the following content:

- "41. Administration of the solarium shall ensure development and implementation of the set of measures aimed at accomplishment of the ban to smoke (consume) tobacco goods on the territory and in the premises of the barber's shop, except for the places specially designated for this purpose."
- 1.9. Add to the Sanitation Norms, Rules and Hygienic Standards "Hygienic Requirements to the Organization, Equipment and Maintenance of the Bathhouses and Saunas" approved by the Ruling No. 27 of the Ministry of Health of the Republic of Belarus, dated March 18, 2009, after paragraph 4, the subparagraph 41 with the following content:
- "41. Administration of the bathhouse shall ensure development and implementation of the set of measures aimed at accomplishment of the ban to smoke (consume) tobacco goods on the territory and in the premises of the bathhouse, except for the places specially designated for this purpose."
- 1.10. Add to the Sanitation Norms, Rules and Hygienic Standards "Hygienic Requirements to the Organization, Equipment and Maintenance of the Laundries" approved by the Ruling No. 28 of the Ministry of Health of the Republic of Belarus, dated March 18, 2009, after paragraph 4, the subparagraph 41 with the following content:
- "41. Administration of the laundry shall ensure development and implementation of the set of measures aimed at accomplishment of the ban to smoke (consume) tobacco goods on the territory and in the premises of the laundry, except for the places specially designated for this purpose."
- 1.11. has expired; (cl. 1.11 has expired. Directive No. 8 of the Ministry of Health, dated 01/25/2013)
- 1.12. Add to the Sanitation Norms, Rules and Hygienic Standards "Hygienic Requirements for the Organization, Maintenance and Business Environment of the Beauty, Tattoo and Permanent Makeup Salons" approved by the Ruling No. 58 of the Ministry of Health of the Republic of Belarus, dated May 29, 2009, after paragraph 4, the subparagraph 41 with the following content:
- "41. Management of the beauty salon shall ensure development and implementation of the set of measures aimed at accomplishment of the ban to smoke (consume) tobacco goods on the territory and in the premises of the beauty salon, except for the places specially designated for this purpose."
- 1.13. Add to the Sanitation Norms, Rules and Hygienic Standards "Hygienic Requirements for the Organization, Equipment and Operation of Swimming Pools and Waterparks" approved by the Ruling No. 105 of the Ministry of Health of the Republic of Belarus on September 22, 2009 "On Approval of the Sanitation Norms, Rules and Hygienic Standards "Hygienic Requirements for the Organization, Equipment and Operation of Swimming Pools and Waterparks" and on Deeming No Longer in Force the Ruling No. 167 of the Chief State Public Health Inspector of the Republic of Belarus, dated December 31, 2002, "On Approval of the Sanitation Rules and Norms 2.1.2.10-39-2002 "Hygienic Requirements for the Organization, Operation and Water Quality in the Swimming Pools", after paragraph 41, the subparagraph 411 with the following content:
- "411. Management of the pool shall ensure development and implementation of the set of measures aimed at accomplishment of the ban to smoke (consume) tobacco goods on the territory and in the premises of the pool, except for the places specially designated for this purpose."
- 1.14. has expired; (cl. 1.14 has expired. Directive No. 83 of the Ministry of Health, dated 06/26/2015)
- 1.15. has expired; (cl. 1.15 has expired. Directive No. 206 of the Ministry of Health, dated 12/27/2012)

- 1.17. In the Sanitation Norms, Rules and Hygienic Standards "Hygienic Requirements for the Labor Conditions of Employees and Operation of Subways" approved by the Ruling No. 135 of the Ministry of Health of the Republic of Belarus, dated October 19, 2010:
- 1.17.1. Add to the Sanitation Norms, Rules and Hygienic Standards, after paragraph 4, the subparagraph 41 with the following content:
- "41. Administration of the subway station shall ensure development and implementation of the set of measures aimed at accomplishment of the ban to smoke (consume) tobacco goods in the underground pedestrian crosswalks adjacent to the subway stations, passenger zones of the subway stations, and in the subway rolling stock, except for the places specially designated for this purpose."
  - 1.17.2. Amend paragraph 14 as follows:
- "14. Garbage cans shall be installed before descents to the pedestrian underpasses adjacent to the subway stations, as well as before the entrance to the booking halls of the subway stations.

"No smoking" signs shall be posted in the pedestrian underpasses adjacent to the subway stations."

2. This Ruling shall become effective in two months after its execution.
