The Organization and Functioning of Committee for Tobacco Products Control

- Having seen the Royal Decree No. NS/RKT/0913/903 dated September 24, 2013 on the Appointment of the Royal Government of the Kingdom of Cambodia;
- Having seen the Royal Decree No. NS/RKT/1213/1393 dated December 21, 2013 on the Reshuffling and Supplementation of Composition of the Royal Government of the Kingdom of Cambodia;
- Having seen the Royal Decree No. NS/RKT/0416/368 dated April 04, 2016 on the Reshuffling and Supplementation of Composition of the Royal Government of the Kingdom of Cambodia;
- Having seen the Royal Kram No. 02/NS/94 dated July 20, 1994 promulgating the Law on the Organization and the Functioning of the Council of Ministers;
- Having seen the Royal Kram No. NS/RKM/0196/06 dated January 24, 1996 promulgating the Law on the Establishment of the Ministry of Health;
- Having seen the Royal Kram No. NS/RKM/0515/004 dated May 18, 2015 promulgating the Law on Tobacco Products Control;
- Having seen the sub-decree No. 67 OrNKr.BK dated October 22, 1997 on the Organization and Functioning of the Ministry of Health
- Receiving the approval from the Council of Ministers in the June 16, 2017 plenary meeting session

CHAPTER 1

General Provision

Article 1 ._

It is required to set up a committee for tobacco products control with acronym of "C.T.P.C" in order to serve as the staffer for the Royal Government in order to educate about and to reduce the consumption of tobacco products.

CHAPTER 2

COMPOSITION

Article 2.

The Committee for Tobacco Products Control "C.T.P.C" has the following composition:

The actua nt.

Article 3._

The members of C.T.P.C are the individuals non-involved with the interests with the industry or company of tobacco products including for instance the share-holding members or the members benefiting from the industry or the company of tobacco products.

CHAPTER 3 DUTIES OF C.T.P.C

Article 4.

The Committee for Tobacco Product Control "C.T.P.C" has the following duties:

- 1- Review and give opinion on the policy, action plan and national strategy for tobacco products control for the health and well-being of the citizen.
- 2- Review and give opinion on various draft laws, law amendments, sub-decrees, circulars, directives and standards in relation to tobacco products control.
- 3- Disseminate, educate and mobilize the engagement from all the milieus in tobacco products control and push forwards to cause engagement from the institution of the Royal Government, non-governmental organizations, private services and the communities in order to enforce the law, sub-decree, directive circular and the researches for effective control of tobacco products.
- 4- Collaborate, track and strengthen the enforcement of various relevant regulations and evaluate the plan, action and national strategy on tobacco products control.
- 5- Coordinate the observation and research of tobacco products consumption and the complications of tobacco products consumption on health and economy.
- 6- Coordinate the study evaluating the quantity of exported and imported tobacco products, the price and tobacco consumption, raw material, machinery, income, tobacco crop cultivation, and other information.
- 7- Perform other duties as assigned by the Royal Government.

Article 5.

C.T.P.C has the National Center for Health Promotion of the Ministry of Health as secretariat with the following duties:

- 1- Prepare and make reports on the meeting of the committee for tobacco products control;
- 2- Liaise with the ministries and institutions with representatives as the members of C.T.P.C;
- 3- Perform other duties as assigned by C.T.P.C;

CHAPTER 4

THE FUNCTIONING OF C.T.P.C

Article 6 ._

C.T.P.C must hold meetings at least twice a year per the president's invitation and can summon an extra-ordinary meeting as necessary per the president's invitation. In case the president has business, the president can hand over the duties to any of the vice-presidents in order to lead the meeting in his/her place.

Article 7.

C.T.P.C shall collaborate with competent authorities, local authorities, civil societies and private sectors in no relation to tobacco industry in order to push forward the program of promotion of tobacco products consumption complication awareness.

Article 8 ._

C.T.P.C has the rights to use the seal belonging to the Ministry of Health in order to operate its work.

Article 9 ._

C.T.P.C shall create sub-committee with acronym of "S.C.T.P.C" in capital and provinces as necessary in order to assist with performance of its work.

Article 10.

The composition and the roles of the sub-committee in capital and provinces must be determined by the decision of the president of **C.T.P.C**.

CHAPTER 5 RESOURCE SOURCE

Article 11 ._

- C.T.P.C must have resource source furnished by national budget in order for operation.
- C.T.P.C has the right to receive and manage and use in accordance with legal procedure in force the funds acquired from development partners and various other sources for the operation of its own work.

Article 12.

The Sub-committees for Tobacco Products Control to be established in the capitals and provinces have resource sources furnished by the national budget package belonging to the capitals and provinces, self and the funds acquired from the development partners and other sources for its own work operation.

CHAPTER 6 FINAL PROVISION

Article 13.

Any provisions that are in contradiction to this sub-decree must be deemed abrogated.

Article 14 ._

The Minister in charge of the Office of Council of Ministers, the Minister of Economy and Finance, the Minister of Health, the ministers of all ministries and the presidents of all related

organizations must undertake the burden to implement this sub-decree according to their respective duties from the date of signature onwards.
