

Regarding the approval of the drafts of warnings about the harm of the consumption of tobacco products and nicotine

Order of the Minister of Health of the Republic of Kazakhstan, dated November 30, 2020. No. KR DSM-222/2020. Recorded with the Ministry of Justice of the Republic of Kazakhstan on December 02, 2020, with No. 21709

Pursuant to the third section of Paragraph 12, of Article 110, of the Code of the Republic of Kazakhstan dated July 07, 2020 "Concerning public health in the healthcare system" I HEREBY ISSUE THIS ORDER:

1. To approve:

- 1) the drafts of the warnings of the harm of the consumption of products with heated tobacco pursuant to Appendix 1 to the order herein;
- 2) the drafts of the warnings of the harm of the consumption of tobacco for a hookah and hookah blend pursuant to Appendix 2 to the order herein;
- 2. Abrogate Order No. 387 of the Minister of Health and Social Development of the Republic of Kazakhstan dated May 26, 2015 "Concerning the approval of the distribution regulations on packages of tobacco products, on the packaging of a tobacco product of information about the contents, the level of the composition of tar substances, nicotine and systemic poisons, carcinogenic and mutagenic substances" (recorded in the National Registry of Normative Legal Documents under No. 11412, published on July 01, 2015 in the "Adilet" legal information system).
- 3. To the Department for the Organization of Medical Assistance of the Ministry of Health of the Republic of Kazakhstan, in the manner prescribed by the law of the Republic of Kazakhstan to ensure:
- 1) the recording of the order herein with the Ministry of Justice of the Republic of Kazakhstan;
- 2) the dissemination of the order herein on the internet resources of the Ministry of Health of the Republic of Kazakhstan after its official publication.
- 3) the submission of information on the measure taken regarding subparagraph 1) and 2) of the subparagraph herein, within ten working days of recording the order herein with the Ministry of Justice of the Republic of Kazakhstan, to the Legal Department of the Ministry of Health of the Republic of Kazakhstan.
- 4. To entrust supervision over the implementation of the order herein order to the acting Vice Minister of Health of the Republic of Kazakhstan.


5. The order herein will take effect ten calendar days following its first official publication.


