**ADMINISTRATIVE INSTRUCTION No.02/ 2024 ON THE AMENDMENT AND
SUPPLEMENTATION OF ADMINISTRATIVE INSTRUCTION (Health) No. 05 /
2023 COMBINED WARNINGS**

Minister of Health,

Pursuant to Article 6 paragraph 13, 18 and 19 of the Law No. 04/L-156 on Tobacco Control (Official Gazette no. 13, 07/05/ 2013), Article 3 and 11 of the Law No. 06/L-113 on the Organization and Functioning of State Administration and Independent Agencies, (OG, No. 07/2019, dt. 01.03.2019), Article 11, paragraph 1, subparagraph 1.5 of the Law No.08/l-117 on the Government of the Republic of Kosovo, Article 38 paragraph 6 of Regulation of the Rules of Procedure of the Government No.09/2011 (Official Gazette no. 15, dt.12.09.2011), the Minister of Health

Issues the following:

ADMINISTRATIVE INSTRUCTION No.02 / 2024 ON THE AMENDMENT AND SUPPLEMENTATION OF ADMINISTRATIVE INSTRUCTION (Health) No. 05 / 2023 COMBINED WARNINGS

Article 1

Purpose

The purpose of this Instruction is to amend and supplement the Administrative Instruction (Health) No. 05 / 2023 Combined Warnings.

Article 2

1. paragraph 1 of Article 11 of the basic Administrative Instruction is amended and supplemented as follows:

1. Effectively from 1 September 2024, all tobacco products that are imported or produced for the market of the Republic of Kosovo must contain health warnings defined in this Administrative Instruction.

2. Paragraph 2 of Article 11 of the basic Administrative Instruction is amended and supplemented as follows:

2. Effectively from 1 March 2025, all tobacco products that circulate in the territory of the Republic of Kosovo must contain health warnings defined in this Administrative Instruction.

3. Paragraph 3 of Article 11 of the basic Administrative Instruction is amended and supplemented as follows:

3. Effectively from 1 March 2025, the circulation on the market of the territory of the Republic of Kosovo of all tobacco products that do not contain the health warnings defined in this Administrative Instruction is prohibited.

Article 3

Entry into force

This Administrative Instruction shall enter into force from the date of publication in the Official Gazette of the Republic of Kosovo.
