#### **Notification**

The 3<sup>rd</sup> Waxing of *Tabaung*, 1375 M.E. (3<sup>rd</sup> March, 2014)

In exercising the power conferred under sub-sections (c) and (d) of section 8 and sub-section (b) of section 19 of the Control of Smoking and Consumption of Tobacco Product Law, the Ministry of Health hereby issues the following Order:

# Order Stipulating the Requirements to be Managed at the Specific Area where Smoking is Allowed

1. The Person-in-charge of the No-Smoking Areas contained in section 7 of the Control of Smoking and Consumption of Tobacco Product Law shall display or hang the following caption and sign-board referring to the Designated Smoking Area at the respective area to be visible by public:

#### "SMOKING AREA"

### "NO SMOKING BEYOND THIS POINT"

## **Penalties Apply**

**Smoking is Dangerous for Health.** 



- 2. The caption and sign-board referred in above paragraph 1:
  - (a) shall be the size not bigger than 18 inches in length and 12 inches in breadth.
  - (b) shall clearly write the warning with black colour on the white background colour.
- 3. The Person-in-charge of other no- smoking area except the trains and vessels transport for passenger contained in sub-section (f) of section (7) of the Control of Smoking and Consumption of Tobacco Product Law, shall manage the **Smoking Area** at the respective area in accord with the following conditions:
  - (a) prescribing the said area out of the building, and at least 10 meters away from the entrance of building;
  - (b) being the area without roof and wall;
  - (c) being the area ensuring that the cigar smoke cannot be spread or reached to the non-smokers at the surroundings.
- 4. The Person-in-charge of the trains and vessels transport for passenger which is not permitted for smoking contained in sub-section (f) of the section (7) of the Control of Smoking and Consumption of Tobacco Product Law shall manage the **Smoking Area** at the respective trains and vessels in accord with the following conditions:
  - (a) being the separate room or place;
  - (b) being the well ventilated place;
  - (c) being the area ensuring that the cigar smoke cannot be spread or reached to the non-smokers at the surroundings.
- 5. If the Person-in-charge fails to comply with any duty contained in paragraphs 1 to 4 of this Order, he shall be taken action under section 16 of the Control of Smoking and Consumption of Tobacco Product Law.
- 6. Whoever commits smoking or holding lighted cigar in any nosmoking area beyond the designated smoking area shall be taken action

under section 17 of the Control of Smoking and Consumption of Tobacco Product Law.
