#### Number 38/2017

# To amend the fees for services provided by Directorate General of Customs

According to the Royal Oman Police Law published vide Royal Decree No. 35/90, and the Royal Decree No. 67/2003 for application of Common Customs Law for the GCC States, approval from Ministry of Finance and for the public interest, it has been decided as follows.
