Subject: Banning e-cigarettes from entering the country

Following our letter number A E G\S – $5811\$ 1 dated 8 October 2012 regarding e-cigarettes entering the country, and referring to the letter of Directorate of Health Promotion and Non-communicable Diseases Director in the General Directorate of Health at the Health Higher Council number TS\A G A\387 dated 15 November 2012, annexed thereto the decree number (7) regarding smoking control issued in the seventieth conference of the thirty sixth session dated 3 February 2011, whereby it decides to "the necessity of complete ban of e-cigarettes in the countries of Gulf Cooperation Council, in consistent with the directions of World Health Organization and recent studies in that regard".

The competent authority of the country is requesting the ban of e-cigarettes to the state of Qatar through all air, land and sea ports, based on the provisions of the law number (20) of the year 2002 AD regarding control of tobacco and its derivatives.

To work on banning e-cigarettes and all similar products from strictly disallow it from entering the state of Qatar, and in case there are suspicious items, it is to be coordinated with the unit of smoking control, Directorate of Health Promotion and Non-communicable Diseases at the Directorate of the General Directorate of Health to whether or not approve them.

To comply, act according to it and take the necessary actions.
