## RESOLUTION NO. 200 dated March 18, 2014

## **ON AMENDMENTS**

TO CERTAIN ACTS OF THE GOVERNMENT OF THE RUSSIAN FEDERATION RELATED TO THE ADOPTION OF THE FEDERAL LAW "ON PROTECTING THE HEALTH OF CITIZENS FROM THE EFFECT OF SECOND-HAND TOBACCO SMOKE AND THE CONSEQUENCES OF TOBACCO CONSUMPTION"

The government of the Russian Federation resolves:

- 1. To approve the attached amendments, which are made to acts of the Government of the Russian Federation related to the adoption of the Federal Law "On Protecting the Health of Citizens from the Effect of Second-Hand Tobacco Smoke and the Consequences of Tobacco Consumption."
- 2. Powers arising from this resolution shall be exercised within the limits established by the Government of the Russian Federation for the number of employees of the corresponding federal executive agencies as well as budget allocations stipulated for these agencies in the federal budget for administration and management in the field of their established functions.

- 1. To supplement the statute on the Ministry of Finance of the Russian Federation, approved by Resolution No. 329 of the Government of the Russian Federation dated June 30, 2004 "On the Ministry of Finance of the Russian Federation" (Collected legislation of the Russian Federation, 2004, No. 31, art. 3258; 2006, No. 32, art. 3569; 2009, No. 3, art. 378; No. 8, art. 973; No. 11, art. 1312; No. 26, art. 3212; No. 31, art. 3954; 2010, No. 5, art. 531; No. 9, art. 967; No. 11, art. 1224; No. 38, art. 4844; 2011, No. 1, art. 238; No. 3, art. 544; No. 10, art. 1415; No. 12, art. 1639; No. 36, art. 5148; No. 46, art. 6522; 2012, No. 20, art. 2562; No. 25, art. 3373; No. 44, art. 6027; No. 49, art. 6881; No. 52, art. 7516; 2013, No. 5, art. 411; No. 36, art. 4578), with subparagraph 5.2.29(2) as follows:
  - "5.2.29(2). Procedure for publication of the minimum retail prices of tobacco products;".
- 2. To supplement the statute on the Ministry of Health of the Russian Federation, approved by Resolution No. 608 of the Government of the Russian Federation dated June 19, 2012 "On Approval of the Statute on the Ministry of Health of the Russian Federation" (Collected legislation of the Russian Federation, 2012, No. 26, art. 3526; 2013, No. 16, art. 1970; No. 20, art. 2477; No. 22, art. 2812; No. 45, art. 5822), with subparagraphs 5.2.207(1) 5.2.207(5) as follows:
  - "5.2.207(1). requirements for a smoking ban sign and the procedure for its placement;
- 5.2.207(2). procedure for the creation and operation of "hot lines," helping to stop tobacco consumption and for the treatment of tobacco dependence;
- 5.2.207(3). procedure for coordination of materials prepared by state agencies of constituent entities of the Russian Federation to inform the population about the harm from tobacco consumption and the harmful effect of

second-hand tobacco smoke on the territory of the respective constituent entity of the Russian Federation;

- 5.2.207(4). list of identification documents (including of a foreign citizen or stateless person in the Russian Federation) and those that allow the buyer to establish the age of the purchaser of the tobacco product;
  - 5.2.207(5). information and communications strategy on tobacco control;".
- 3. To supplement the statute on the Ministry of Construction and Housing and Utilities of the Russian Federation, approved by resolution No. 1038 of the Government of the Russian Federation dated November 18, 2013 "On the Ministry of Construction and Housing and Utilities of the Russian Federation (Collected legislation of the Russian Federation, 2013 No. 47, art. 6117) with subparagraph 5.2.101(1) as follows:
- "5.2.101(1). requirements for the allocation and equipping of special places outdoors for smoking tobacco, for the allocation and equipping of isolated rooms for tobacco smoking (jointly with the Ministry of Health of the Russian Federation);".
