# ADMINISTRATIVE ORDER NO. 139/2013/MS/CAB/DGS/DSSP OF AUGUST 20, 2013, DETERMINING THE TEMPLATES FOR SIGNS BANNING SMOKING IN PUBLIC PLACES AND INDICATING AREAS SET ASIDE FOR SMOKERS

# THE MINISTER OF HEALTH,

In light of Law n° 2009-007 of May 15, 2009, concerning the code of public health of the Republic of Togo;

In light of Law n° 2010-017 of December 31, 2010, concerning the production, commercialization, and consumption of cigarettes and other tobacco products;

In light of Decree n° 2012-004 /PR of February 29, 2012, concerning the attributions of the Ministers of State and Ministers;

In light of Decree n° 2012-046 /PR of July 11, 2012, concerning the prohibition of smoking in public places;

In light of Decree n° 2012-051/PR of July 19, 2012, concerning the nomination of the Prime Minister;

In light of Decree n° 2012-056/PR of July 31, 2012, concerning the composition of the government, together with the texts of its amendments;

# **ORDERS:**

**Article One:** The purpose of this Administrative Order is to define the formats for pictograms of signs in smoke-free public places and the indication of areas set aside for smokers.

This Administrative Order is accompanied by annexes comprising an integral part hereof.

<u>Art. 2</u>: Signs reminding people of the principle of banning smoking in public places are to replicate the template in Annex 1 of this Administrative Order.

Former signs in use prior to the entry into force of this Administrative Order must be replaced by the template reproduced in Annex 1 of this Administrative Order.

Any other kind of sign is considered to be invalid.

- <u>Art. 3</u>: The signs to be posted at the entrance to areas set aside for smokers are to replicate the template in Annex 2 of this Administrative Order.
- <u>Art. 4</u>: These signs must comply with the graphic provisions set forth in Annex 3 of this Administrative Order.
- <u>Art. 5</u>: These signs must be posted in such a way that they are visible and legible to the public and employees.
- <u>Art. 6</u>: The Director General of Health is charged with the execution of this Administrative Order, which is to be published in the Official Journal of the Republic of Togo.

- 3. The templates for signs and indication of areas must be printed on a minimum format of 15 x 21 cm (A5), without restrictions on parallel enlargement.
