From the Tobacco and Alcohol Market Regulation Board:

THE REGULATION ON CHANGES TO BE MADE TO THE REGULATIONS REGARDING THE

PROCEDURES AND PRINCIPLES ON THE SALE AND PRESENTATION OF

TOBACCO PRODUCTS AND ALCOHOLIC BEVERAGES

- **ARTICLE 1** In Article 4 of the Regulation Regarding the Procedures and Principles on the Sale and Presentation of Tobacco Products and Alcoholic Beverages number 27808 dated 7/1/2011, the expression "presentation of tobacco goods for hookah use" shall be added as shown below, after the expression "tobacco products sales in workplaces" that is included in clause (i).
- "m) The person presenting tobacco goods for hookah use: is a real individual or legal entity who possesses a compliance certificate and opens the market prepared package of the hookah tobacco goods and presents it to the final user in accordance with the regulation,"
 - **ARTICLE 2** The following clause has been added to article 5 of the same regulation.
- "f) A compliance certificate for the presentation of hookah tobacco in order to sell hookah tobacco through presentation."
 - **ARTICLE 3** The following clause has been added to article 6 clause one of the same regulation.
- "h) Hookah tobacco cannot be presented in areas that have been prohibited for tobacco use in accordance with Regulation no. 4207."
- **ARTICLE 4** The expression "to people who present hookah tobacco" has been added to follow the expression "These people to people who sell open alcohol directly" that is in the (a) matter of clause one in Article 7; the expression "except for water pip tobacco sales that are done towards hookah smoking places" in the first sentence of clause (c) has been removed from enforcement.
- **ARTICLE 5** The title of Article 10 in the same regulation has been changed as follows and the below clause has been added to the article.
- "Principles regarding businesses that involve retail open alcoholic beverage sales and presentation of tobacco for hookahs"
- "(4) The principles and procedures for hookah tobacco presentation operations and businesses are determined by a communique that is issued by the Board."
- **ARTICLE 6** The expression "with the hookah tobacco presentation compliance certificate" has been added after the expression "retail and open alcoholic beverage sale certificate" included in article 12 of the same regulation, and the expression "a business opening and operating license sample and/or a tourism operation certificate with a letter of compliance that will be obtained from the authorized offices" is added after the phrase "permit certificate sample" which is in sub-clause (1) of clause (a) in article two and sub-clause (1) of clause (b).

ARTICLE 7 – The following has been added to article 13 of the same regulation.

"(15) The principles and procedures that have been determined in the organization of sales certificates are also valid for the hookah tobacco goods presentation compliance certificate."

ARTICLE 8 – The following clause has been added to article 14 of the same regulation.

"(6) The principles and procedures regarding time extension and the validity of sales certificates are also valid for the hookah tobacco goods presentation compliance certificate."

ARTICLE 9 – The expression "and to businesses that provide hookah tobacco goods" has been added after the expression "to the sellers of open alcoholic beverages by authorized administrators with business opening and operating permits" that is included in article 26 of the same Regulation.

ARTICLE 10 – The following article has been added to the same Regulation.

"The state of violation towards the activities of existing hookah tobacco smoking locations

TEMPORARY ARTICLE 7 – (1) The existing hookah tobacco smoking places; must bring their place up to compliance with the regulations that are brought into force with this article within six months of the date that these articles go into force."

ARTICLE 11 – This regulation goes into force as of the date that it is published.

ARTICLE 12 – The Tobacco and Alcohol Markets Regulation Board Chairman enforces the provisions of this Regulation
